Guidelines for Payment of Mission Trips and Outreach Programs

As of the October 14, 2008 meeting and after consultation with the Finance Chairperson, the following guidelines have been set up for payment of funds received through the Liberty Chapel Fair Food Stand and approved by the full committee. These guidelines will be reviewed annually.

Payment will be considered for any Liberty Chapel Administrative Council approved mission trip to the leader of such group arranging for the trip. Payment will be made for all members of the trip, members and non-members of Liberty Chapel alike. A written list of those participating in the trip, where the trip is to and the purpose of the trip should be brought to our attention.

Payment will also be considered to outreach programs, such as 'Project: We Care', and 'Caring Cupboard', as examples. Programs that are brought to our attention will be decided by a majority of committee members.

Payment will also be made on a yearly basis to the Men's group and the Women's group in recognition of the help and participation they provide. Payments will be as follows:

Mission trip members - \$100/person per trip, \$1,000 maximum per trip (or as needed and funds permitting)

Outreach Programs - \$100 per program (or as needed and funds permitting)

Men's Group - \$500 per year

Women's Group - \$500 per year
